

The Apostolic Nunciature in Latvia presents its compliments to the Ministry of Foreign Affairs of the Republic of Latvia – State and Diplomatic Protocol – and writes in reference to the Covid vaccination cards and certificates that have been issued by the Vatican City State (VCS).

The Apostolic Nunciature in Latvia communicates that the European Commission has decided to recognize the digital Covid certificates issued by the VCS thus allowing it to participate in the Digital Covid Certificate Gateway. As a result, the VCS will issue an EU Digital Covid Certificate (green pass) to all those who were vaccinated against Covid-19 at the Vatican medical centre. In transmitting an example of the certificate in question, the Holy See kindly requests that said certificate be recognized by the health authorities of the Republic of Latvia (enclosure).

The Apostolic Nunciature in Latvia avails itself of this opportunity to renew to the Ministry of Foreign Affairs of the Republic of Latvia – State and Diplomatic Protocol – the assurances of its highest consideration.
